

## Resource Persons:

Prof. Harold J. Berman, Story Professor of Law, Harvard University. Prof. Berman's courses include The Western Legal Tradition, Comparative Soviet and American Law, and The Law of International Trade. He has authored sixteen books and over 150 articles. His books include The Interaction of Law and Religion (1974), Justice in the U.S.S.R. (rev. ed., 1963) and The Nature and Functions of Law (3rd ed., 1972 with William R. Greiner).

Prof. Berman was born in 1918 in Hartford, Conn. He received the B.A. degree from Dartmouth College in 1938 and his law degree from Yale University in 1947.

Mr. David R. Nissen graduated from Wheaton College with an A.B. in history in 1954. He received the M.A. and J.D. degrees from the University of Illinois, graduating from the Law School in 1961. Following military service in the Counter-Intelligence Corps, he joined the Anti-Trust Division of the Justice Department. He has held several public law posts of national significance and from 1971-73 he was Special Attorney for National Litigation with the U.S. Department of Justice. He is presently a partner in the law firm of Passo, Yates & Nissen in Santa Ana, California.

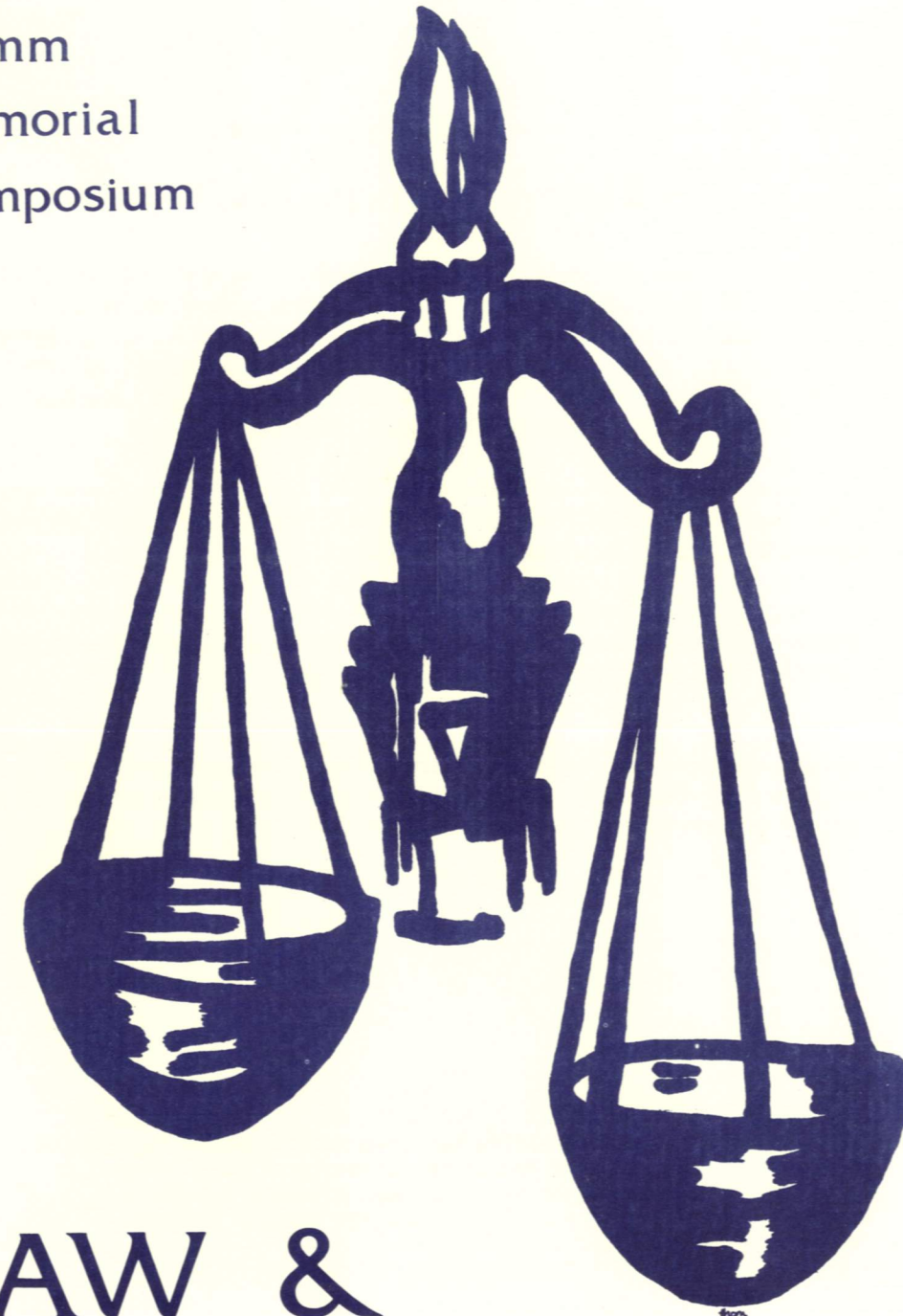

## S. Richey Kamm, Ph.D.

S. Richey Kamm served as professor of history and political science at Wheaton College for 34 years. A graduate of Greenville College, he received his Ph.D. in history from the University of Pennsylvania. He was appointed to the Wheaton College faculty in 1940 and subsequently served with distinction in many critical roles.

He was a Fulbright lecturer at Dacca University, Bangladesh (then East Pakistan) where he established the first post-graduate course in American history.

His recognition beyond Wheaton was evidenced by honorary degrees from three colleges, Greenville College, Seattle Pacific College, and Whitworth College.
